## CALL FOR NOMINATIONS ON THE 6<sup>TH</sup> ASEAN RURAL DEVELOPMENT AND POVERTY ERADICATION AWARDS

To: Assistant Regional Director Schools Division Superintendents All Others Concerned

1. Relative to the Memorandum No. ICO-A-DM-0096-051023 from External Partnerships Service entitled **Request to Disseminate Information Regarding the 6th Association of Southeast Asian Nations (ASEAN) Rural Development and Poverty Eradication Awards (RDPLA)** by the National Anti-Poverty Commission (NAPC), Schools Division Offices are requested to assess and nominate possible leadership awardees for the 6th ASEAN Rural Development and Poverty Eradication Awards.

2. The objectives of the Leadership Awards are as follows:

- a. Recognize the roles, outstanding achievements and contributions of NGOs, CSOs, and the private sector in the Philippines to the rural and community development, livelihood, and poverty reduction of local communities;
- b. Encourage the NGOs/CSOs and private sector to continue and strengthen their work and contributions to rural and community development, and poverty eradication in the country and, in a broader context, to the ASEAN Community Vision 2025;
- c. Promote inclusiveness through closer cooperation and partnerships between the government, NGOs/CSOs, and the private sector in developing rural areas/communities and eradicating poverty in the country and other ASEAN Member States (if any); and
- d. In the spirit of promoting a people-oriented ASEAN, strengthen ASEAN Centrality amongst NGOs/CSOs and the private sector and bring ASEAN closer to people's hearts.

3. School Division Offices with qualified local organizations and private sector partners shall submit their nominations with required attachments in a single PDF file to the Regional Office HRDD through the link: https://tinyurl.com/6ASEANRDPLA on or before June 1, 2023.

- a. Endorsement by the SDO
- b. For national or local organization: Philippine Council for NGO Certification (PCNC) or Cooperative Development Authority (CDA) or Security and Exchange Commission (SEC) Registration
- c. For Private Sector: SEC Registration/DTI-PEZA/Bureau of Immigration (BI) Registration

- d. Certification of Operation for 3 years
- e. Implemented Programs, Projects and Activities that significantly contribute to rural/community development
- f. Minutes of the meetings and photo documents
- g. Certificates received
- h. Certification of not funded organization/conduit
- i. Awards received
