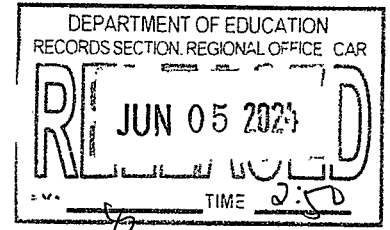

**WORKSHOP TO ESTABLISH A REGIONAL CULTURAL LEARNING STANDARD IN

1. Relative to the implementation of IPed Program that supports the realization of the MATATAG Curriculum, adhering to inclusive, culturally sensitive and adaptable standards, enabling schools to localize, indigenize and enrich based on community's context, this office through the Curriculum and Learning Management Division will conduct a *Workshop on the Establishment of Regional Learning Standard* on August 7 to 9, 2024.
