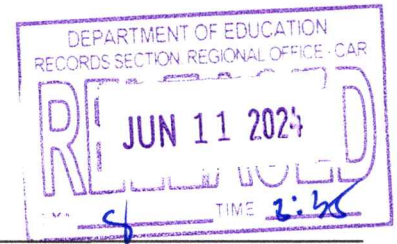

5. The personnel involved in the conduct of on-site validation are the staff of the Quality Assurance Division (QAD), and the members of the Regional Inspectorate Team for Schools (RITs).
6. The results and findings of the said activity shall be presented to and deliberated by the Regional Inspectorate Team for schools (RITs) during the Post Validation Conference to come up with a collegial decision and appropriate actions for the applications being evaluated and validated.
7. The Schools Division Superintendents are hereby advised to inform the concerned schools to ensure that school heads and staff shall be in their respective schools during the cited ocular inspection/on-site validation schedules.
8. Immediate dissemination of and strict compliance with this memorandum are desired.
