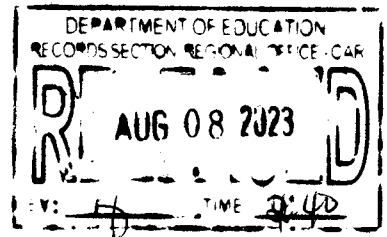

In 2022, the Department of Education (DepEd), through the Bureau of Alternative Education (BAE), adopted the Be Your Own Boss (BYOB) and Work-Based Learning (WBL) programs to be pilot implemented in the Opportunity 2.0 (O2) sites. The BYOB and WBL programs aim to provide venues for the Alternative Learning System (ALS) learners to engage in entrepreneurial activities and expose them to the world of work in preparation for earning a living through employment and entrepreneurship. These programs are responsive to DepEd's MATATAG Agenda to produce competent, job-ready, active and responsible citizens.

BAE is currently implementing the BYOB and WBL programs and plans to expand their implementation and come up with the policy for its adoption/implementation/integration into the ALS K to 12 Basic Education Curriculum (BEC).

In this relation, Regional Offices are requested to submit a list of Schools Division Offices (SDOs) that intend to participate in the expansion/scale-up of the implementation of BYOB and WBL.
