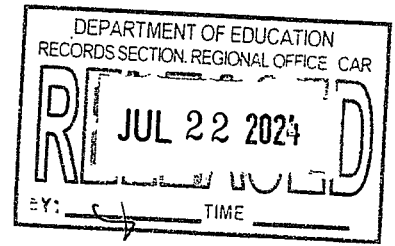

**EVALUATION OF THE IMPLEMENTATION OF THE NATIONAL LEARNING CAMP (NLC) AND REMEDIAL CLASSES**

To: Schools Division Superintendents  
All Schools Division Offices  
All Others Concerned

1. Pursuant to DepEd Memorandum DM-CT-2023-242, the Department of Education (DepEd) through the Bureau of Learning Delivery (BLD) will evaluate the implementation of the **2024 National Learning Camp (NLC) and Remedial Classes**. To effectively evaluate the said program, this office requests the assistance of the Schools Division Offices to facilitate the completion of survey questionnaires to be accomplished by the Learning Camp Volunteers (LCVs) and School Heads of NLC participating schools.

2. The survey tool can be accessed through the Learning Management System (LMS) using the URL link: [https://bit.ly/NLC2024\\_CAR](https://bit.ly/NLC2024_CAR)

3. The participants will be guided by the reminders below:

a. **One-time Official Access:** Only the official respondents shall access the portal and accomplish the survey questionnaires. This is to avoid duplication of responses, thus maintaining the validity and reliability of the survey. The official respondents are the School Heads and LCVs of NLC participating schools.

b. **Single Response:** all official respondents shall complete the survey questions only once.

c. **Complete Responses:** Respondents shall answer each question one after the other. Every question is a prerequisite to the next.

d. **Certificate Generation:** Certificate for LCVs and School Heads shall be generated upon the successful completion of the survey. The generation of the certificates is open from July 19 to August 19, 2024 only.

4. All LCVs who handled NLC classes shall receive a Certificate of Recognition and a Certificate of Learning & Development, while those who taught Remedial Classes shall receive a Certificate of Recognition as teacher volunteers.

5. For **Non-DepEd Learning Camp Volunteers:** log in the PD using your Gmail account.


