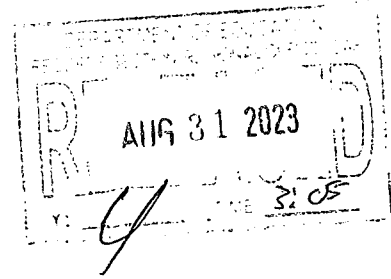

**CONDUCT OF PHILIPPINE INFORMAL READING INVENTORY (Phil-IRI) PRE-TEST
FOR SCHOOL YEAR 2023 - 2024**

To: Assistant Regional Director
Schools Division Superintendents
Division English and Filipino Supervisors
All Others Concerned

1. In compliance with DepEd Order No. 14, s. 2018 titled ***Policy Guidelines on the Administration of the Revised Philippine Informal Reading Inventory***, the Regional Office directs all English and Filipino teachers in the Schools Division Offices (SDOs) to conduct the **Phil-IRI PRETEST** to learners in Grades 3 to 7 (Filipino) and Grades 4 to 7 (English) in all elementary and secondary schools **who scored below 14 in the Group Screening Test (GST)**. This shall be conducted from September 4 to October 20, 2023.
2. Learners who are identified under the frustration level (*both in oral and comprehension*) shall be provided with necessary interventions such as but not limited to intensive remediation and school-home partnership. An Intervention Plan shall be prepared and submitted to the Schools Division Office for consolidation and submission to the Regional Office – CLMD.
3. School Heads and Language Supervisors shall provide necessary support to upskill and reskill teachers in the provision of appropriate interventions and shall ensure that learners will be promoted to higher grade level equipped with the required decoding and comprehension skills.
4. The Focal Persons for Phil-IRI in English and Filipino in each Schools Division Office (SDO) shall facilitate and collate the results of the Pre-Test and submit the **results with analysis** to CLMD Email: ***car.clmd@deped.gov.ph*** on or before October 31, 2023.
5. A schedule of monitoring from the Regional Office shall be made to ensure the implementation of Phil-IRI in all schools in the region.


