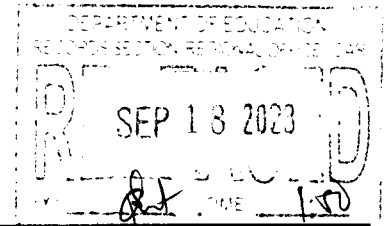



1. This has reference to **DepEd Order (DO) 21, s. 2023** titled, “*Brigada Eskwela Implementing Guidelines*” dated **August 03, 2023**. **2023 BRIGADA ESKWELA IMPLEMENTATION GUIDELINES**

*(based on DepEd Order No. 21 s. 2023)*

- Classroom walls shall remain bare and devoid of posters, decorations, or other posted materials
- Classroom should not be used to stockpile materials and should be clear of other unused items or items for disposal
- Classroom wall paint should follow the prescribed color
