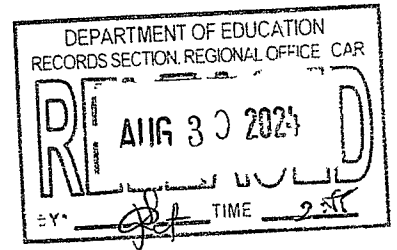

**ORIENTATION AND REORGANIZATION OF REGIONAL CONSULTATIVE ADVISORY BODIES ON INDIGENOUS PEOPLES EDUCATION (IPEd) CUM DEVELOPMENT OF 2025 REGIONAL STRATEGIC PLAN**

1. Relative to DepEd order No. 62, s. 2011 entitled *Adopting the National Indigenous Peoples Policy Framework* and DO 43, s. 2013 entitled *Implementing Rules and Regulations of Republic Act. No. 10533* Otherwise Known as the Enhanced Basic Education Act of 2013, and consistent with the Rights-Based Approach (RBA) this office through the Curriculum and Learning Management Division (CLMD) shall conduct an *Orientation and Reorganization of all the Members of the Division Consultative Advisory Bodies and Development of the 2025 Regional Strategic Plan* on September 10 to 12, 2024. The venue will be announced in a separate memo.

2. The objectives of this activity are the following:
- gather all the members of the Division CABs who shall then select among themselves representatives to constitute the Regional CAB.
  - orient new members on the role and functions of the CAB and on other basic information on the IPEd Program and DepEd systems and processes
  - update the CAB members on developments on the IPEd Program and other concerns that may have implications for IPEd;
  - develop regional strategic plan; and
  - discuss other important matters

3. In relation to the above activity, the SDO shall organize a gathering of IP elders and community representatives involved in the formulation of the IPEd Framework and other community engagement activities (e.g., those who were involved in curriculum contextualization). During this assembly, participants will select members to constitute the Division CAB.

4. The Division CAB will attend the Reorganization and Orientation of Regional Consultative Advisory Bodies on Indigenous Peoples Education (IPEd) cum Development of 2025 Regional Strategic Plan.
