#### CALIBRATION OF WEIGHING SCALES

- In line with Republic Act 9236, also known as the National Metrology Act of 2003, which provides measurement standards that are internationally traceable and consistent with the Meter Convention, complying with international standards, the Department of Science and Technology-CAR through the Regional Metrology Laboratory (RML) provides calibration services to weighing equipment.
- 2. To ensure the accuracy of weighing equipment and to minimize errors in the measurement of learners' weight, the Department of Education-CAR, through the Education Support Services Division (ESSD), in partnership with the DOST-CAR RML, will conduct calibration of weighing scales.
- The schedule of calibration and the corresponding number of weighing scales 3. for calibration per SDO are as follows:
