## 2024 REGIONAL INDIGENOUS PEOPLES MONTH CELEBRATION

1. Pursuant to Proclamation No. 1906 as National Indigenous Peoples (IP) Month and Proclamation No. 486 declaring October 29 of every year as National Indigenous Peoples Thanksgiving Day, the Department of Education-Cordillera Administrative Region (DepEd-CAR) shall conduct the *2024 Regional Indigenous Peoples Education on October 27-29, 2024,* in Apayao.

2. The objective of this activity is to promote awareness on the indigenous knowledge, systems, and practices of the Cordillera Administrative Region.

- Specifically, it aims to:
- a. showcase the cultural heritage and practices in the region and;
