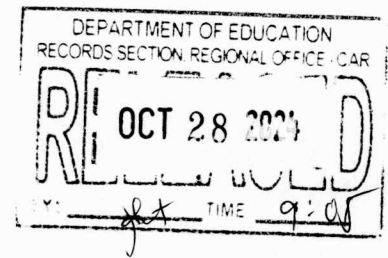

NATIONAL CHILDREN'S MONTH**

1. The Department of Education-Cordillera Administrative Region (DepEd-CAR) joins the Council for the Welfare of Children (CWC), the National Youth Commission (NYC), the Department of Social Welfare and Development (DSWD), local government units, and private organizations, including civil society, private enterprises, nongovernment, civic, and people's organizations, and the whole nation in celebrating the 32nd National Children's Month (NCM) with the theme, *Break the Prevalence, End the Violence: Protecting Children, Creating a Safe Philippines!*
2. The celebration is in line with Republic Act No. 106611, which declared the month of November every year as the National Children's Month, commemorating the adoption of the United Nations Convention on the Rights of the Child (UNCRC) on November 20, 1989, seeking to promote the protection of children's rights. Section 4 of the Act thereof mandates DepEd to facilitate and encourage the observance of the NCM in all schools, public and private, nationwide.
3. A Regional Celebration of the National Children's Month will be conducted at Guina-ang Elementary School, Guina-ang National High School, and Saclit Elementary School, Mountain Province on November 12-13, 2024.
4. The Regional Office encourages all division offices and all schools, public and private, to celebrate National Children's Month in a manner that is distinctive to them.
5. All public and private schools must submit photo documentation or video proof showcasing how they celebrated National Children's Month to the Regional Office on or before November 19, 2024.
