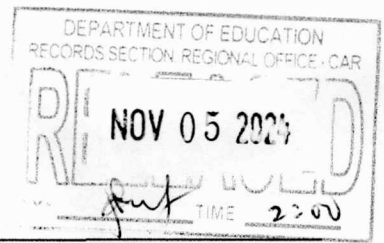

**DIVISION ASSIGNMENTS ON THE REDEVELOPMENT
OF TLE/TVL LEARNING RESOURCES**

1. In reference to Memorandum DM-OUHROD-2024-156, the Department of Education assigns DepEd – CAR in the production and redevelopment of Self-Learning Modules (SLMs) for EPP/TLE Industrial Arts aligned with the MATATAG Curriculum.
2. In view thereof, this Office through the Curriculum and Learning Management Division (CLMD) assigns each Schools Division Office (SDO) the task to develop the modules for Grades 5, 6, 9 and 10. Attached Enclosure 1 is the list of specialization assignments for all Schools Division Offices.
3. The SLMs to be developed must comply with the guidelines and elements stated in Regional Memorandum 91, s. 2020 as well as the quality assurance process established by the LRMS. Additionally, the content must align with the learning competencies specified in the MATATAG Curriculum.
4. The developed module shall undergo a Quality Assurance process at the division level before being submitted for the Regional QA process. This ensures that the materials are free from content, language, layout, and format errors, plagiarism and copyright infringement. Additionally, this module must comply with the prescribed module elements using Learning Resource QA Tool and Form.
5. The Division Education Program Supervisor (EPS) in-charge of LRMS with the assistance of the EPP/TLE/TVL Division EPS shall be responsible for submitting the modules and evaluation tools.
6. The digital copies of the ADM modules developed shall be submitted in word document and pdf format to **car.lrmads@deped.gov.ph** through the Regional EPS in-charge of LRMS on or before December 6, 2024.
7. The funds allotted for the said activity shall be charged against the funds downloaded to the Division LRMS subject to accounting guidelines and regulations.
