**TRAINING-WORKSHOP FOR ASATIDZ ON CULTURALLY
RESPONSIVE TEACHING PEDAGOGY**

1. In line with the In-Service Training Program for Asatidz, the Regional Office through the Curriculum and Learning Management Division (CLMD) will conduct a three-day Training-Workshop on Culturally Responsive and Gender Sensitive Teaching Pedagogy on October 24-26, 2018 at a venue to be announced later.
 2. The activity aims to:
