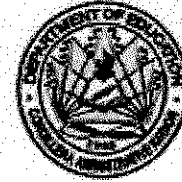

Subject: **Conduct of Regional Monitoring on the Read to Learn Training by Ronald McDonald House Charities, Inc. (RMHC)-Post Test Phase**

Date: **January 11, 2017**

- Relative to the Ronald McDonald Read to Learn Program for SY 2016 to 2017, a total of 405 schools offering Multigrade Education and Primary Education Programs received a Read to Learn Kit (composed of 34 big books, lesson guides, and worksheets) and a Beginning Training for educators in Summer of 2016.
- As part of the Read to Learn Program component, the Regional Office, in partnership with RMHC, will be conducting a monitoring activity which includes a post-test from *January 30 to February 3, 2017* to the 40 schools pretested in July 2016.
- Objectives of this monitoring activity-post test phase will be: a) to evaluate the impact of the Beginning Reading Training to the teachers and learners; b) to assess the extent of usefulness and relevance of the Read to Learn Kit distributed during the training; and c) to address emerging concerns or issues relative to the program.
- Monitoring team will be composed of one supervisor from the Regional Office through the CLMD and ESSD, one personnel from the RMHC, and the SDO supervisor in-charge of Multigrade. The Schools Divisions are requested to provide lodging and transportation since the RO has limited provisions for such. RMHC will shoulder gas and other incidental expenses.
