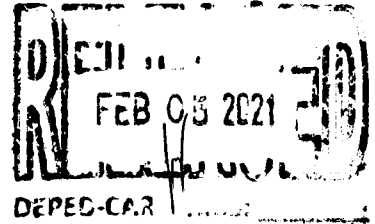

**REITERATION ON THE STRICT ADHERENCE TO THE SOCIAL CONTENT
ELEMENT OF LOCALLY-DEVELOPED LEARNING RESOURCES**

All Others Concerned

1. In line with the thrust of ensuring the continuity of learning in basic education amidst COVID-19 pandemic, DepED-Cordillera Administrative Region ensures that only quality assured Self-Learning Modules shall be the primary learning materials in the delivery of distance learning.
2. Relative to the recent issues made viral on social media as regards social content issues of learning resources, specifically seen in the Self-learning modules, this Office urgently calls the attention of Schools Division Offices to make urgent and necessary actions.
3. All SDOs are directed to review their locally-developed SLMs or Learning Activity Sheets to ensure that these are strictly complying to the social content standards incorporated in the LR Evaluation tools.
4. Learning Resources still found to be inconsistent with the standards after uploading and public sharing with schools, shall be tracked. Personnel found to be accountable for lapses as regards the development, evaluation or quality assurance, and uploading of these erroneous learning resources, shall be subject to appropriate sanctions.
5. Further, this Office reiterates to all Schools Division Offices and Stakeholders to help in creating awareness about indigenous peoples and be part of correcting learning materials by searching and providing details of the erroneous learning material as to **learning area, quarter, week and Division of the developers.**
