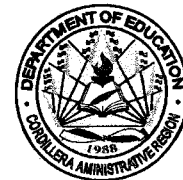

Subject: **Regional Training on Developmentally-Appropriate Practices in Early Language, Literacy, and Numeracy**

Date: **February 17, 2017**

1. With reference to DepEd Memorandum No. 220, s. 2016 entitled Developmentally Appropriate Practices in the Early Language, Literacy, and Numeracy Training Program, DepEd-CAR will conduct the **Regional Training on Developmentally-Appropriate Practices in ELLN** on April 17 to 23, 2017 for Cluster 1 and on April 25 to May 1, 2017 for Cluster 2 at a venue to be informed later in a subsequent memorandum.
2. The purpose of the Training Program is to develop in Filipino children literacy and numeracy skills and attitudes, which will contribute to lifelong learning.
3. Participants will come from 40% of the teachers, school heads, and supervisors trained during the first ELLN regional and division trainings. Cluster 1 will be composed of participants from the Divisions of Abra, Baguio City, Benguet, and Mountain Province. Cluster 2 will be composed of participants from the Divisions of Apayao, Ifugao, Kalinga, and Tabuk City.

Participants are expected to bring their laptops, extension cords, Standards and Competencies for Kindergarten, and ECCD Tool.
7. Accommodation and meals (breakfast, lunch, dinner, morning and afternoon snacks) for 7 days will be charged to downloaded funds for LEAPS Regions. First meal for Cluster 1 will be dinner of Sunday, April 16 (Cluster 1) and last meal will be afternoon snacks of Sunday, April 23. First meal for Cluster 2 will be dinner of Monday, April 24 and last meal will be afternoon snacks of Monday, May 1.
8. Travel expenses and other meals not covered within the workshop duration will be charged to local funds subject to the usual accounting and auditing rules and regulations.
9. Participants and Training Management Team will be entitled to service credits or compensatory time off (CTO) as per CSC and DBM Joint Circular No. 2, s. 2015 in lieu of April 16 and 23 for those attending Cluster 1 and April 29, 30, and May 1 for those attending Cluster 2.
10. School heads of teacher participants are encouraged to take appropriate actions to avoid disruption of classes. School heads must make arrangements with available teachers in the school to take charge of classes of teachers who will be attending the training.
