

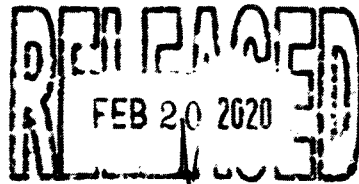

1. The DepED-CAR Legal Unit in coordination with the and ICT Unit of the DepEd-CAR Regional Office and selected Schools Division personnel, conducted the Legal Services Year-End Monitoring, Evaluation and Assessment, and Planning of Programs and Activities for C.Y. 2020 on January 21-24, 2020 where one of the highlights of the activity is the presentation of the first draft of the Gender Responsive and Non-Discriminatory Student Discipline Manual (GRaNdSDisM) to the participants for further comments, review, inputs and suggestions;
2. All the comments, inputs and suggestions from the participants were incorporated to come up with the second draft of the Manual. Attached is a copy of the second draft of the GRaNdSDisM as **Annex A**
3. To further enhance the said Manual, an extensive consultation will be conducted by the Schools Division Offices in partnership with the Local Government Units, Parents-Teachers Associations, and other stakeholders as planned and agreed upon by the Technical Working Committee (TWC). Attached as **Annex B** is the list of the TWC for the drafting of the GRaNdSDisM;

barangay CPC representatives, students, and teachers to get their comments, suggestions, inputs and other important matters necessary for the finalization of the Manual;

5. Considering that the consultation will require funding, it is encouraged and enjoined that available resources such as PTA funds, SSG funds, Association funds, GAD funds and MOOE of the SDOs or selected schools as venue for the said consultations, may be requested and utilized for the said purpose. Each SDO should conduct at least one (1) consultation or series of consultations among the different stakeholders provided that parents, teachers, students, school heads, community representatives are represented or consulted;
6. The inputs, suggestions, and comments from the series of consultations that will be conducted will be consolidated during the first quarter interface on March 18-20, 2020. In this regard, the SDOs will submit its report with inputs not later than March 16, 2020 through the Legal Unit e-mail address;
7. The finalized Manual will serve as a guide for the effective implementation of the child protection policies of the public schools and learning centers within the Region in conformity with the standard procedures that are gender and culturally sensitive.
8. Immediate compliance to this Memorandum is highly appreciated.
