Date : MARCH 7, 2016

1. Pursuant to Republic Act No.10533, the Enhanced Basic Education Program and the IPED provision of its implementing Rules and Regulations (sec.8.4), mandates DepEd to develop a curriculum that is culture-sensitive, contextualized, and flexible enough to enable and allow schools to localize, indigenize and enhance based on the specific educational and social context of communities. In support of this mandate, the Department of Education-Cordillera Administrative Region will conduct a one (1) day Regional Coordination Meeting on March 17, 2016 at the Stephen N. Capuyan Hall to plan for the Seminar- Workshop on Contextualization of Junior High School Modules.
