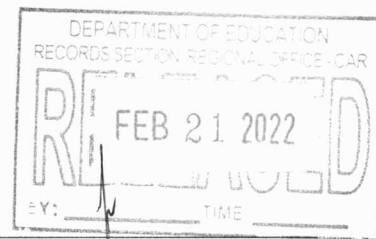

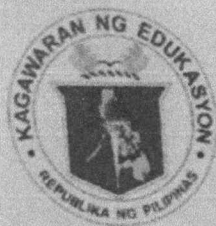


- a. Financial status of the organization.
