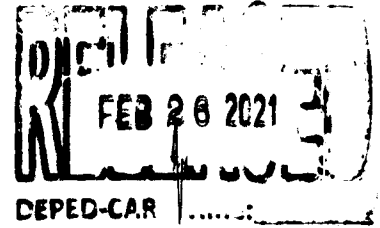

**GUIDELINES ON THE UTILIZATION OF THE DOWNLOADED 2021 IPED and
 ELLN TO IMPLEMENTING SDOs**

1. The Department of Education-Cordillera Administrative Region issues the Guidelines on the Utilization of the Downloaded 2021 Funds for the Indigenous Peoples Education (IPed) and the Early Language Literacy and Numeracy (ELLN).
2. The Downloaded IPED Fund shall be utilized for the contextualization of learning resources and other IPed's plans and priorities in accordance with DO 22, s. 2018 entitled "Amended Multi-year Implementing Guidance on the Allocation and Utilization of the Indigenous People Education (IPED) Program Support Fund (PSF)" and the ELLN Fund shall be utilized for the conduct of Learning Action Cells (LACs).
