

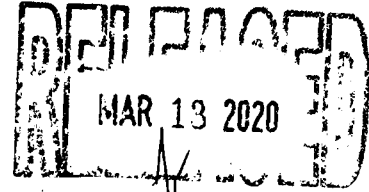

**TRACKING OF STATUS OF PRIVATE SCHOOLS IN THE DEPARTMENT OF EDUCATION – CORDILLERA ADMINISTRATIVE REGION**

- Per Regional Memorandum No. 189, s. 2019 “Status of Private Schools re: Government Permit Recognition”, the result of the validation of status of private schools vis-à-vis the data generated from the Enhanced Basic Education Information System (EBEIS) and the Learner’s Information System (LIS) indicates that some information or data concerning these private schools need to be updated. This data includes the ff:
  - Issued Government Permit/Recognition (establishment and validity)
  - Articles of Incorporation (SEC Registration)
  - Documents of school ownership
  - School address or location
  - Grade level or course offering
  - No. of learners, teachers, and other staff
  - School development plans
- With the foregoing, the proposed online database shall serve as a monitoring tool in order to easily track the status of private schools. It also lessens the time being consumed in locating records of these schools. Further, it contributes in the achievement of DepED-CAR’s aim to standardized processes, systems and guidelines relative to regulatory services. Therefore, this system shall be adopted.
- The Quality Assurance Division (QAD) in coordination with the Office of the Regional Director – ICT Unit (ORD-ICTU) shall regularly monitor the usage and effectivity of the system. Further, updates on the status of private schools in the region shall be regularly reported during the quarterly Monitoring and Evaluation Adjustment (MEA) activities.
