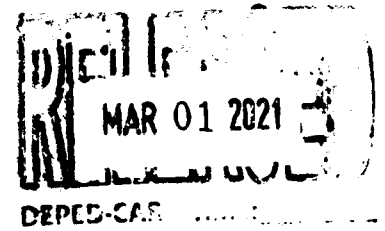

**CONTINGENCY MEASURES TO ENSURE UNINTERRUPTED DISTANCE
LEARNING DELIVERY FOR QUARTER 3 OF SCHOOL YEAR 2020-2021**

TO: OIC-Assistant Regional Director
Schools Division Superintendents
All Schools Division Offices
All Others Concerned

1. Pursuant to the Basic Education Learning Continuity Plan (BE-LCP) and ensuring the continuity of learning in the education amidst COVID 19 pandemic, the Regional Office through the Curriculum and Learning Management Division (CLMD) reiterates contextualized mechanisms and measures in the implementation of Distance Learning Delivery Modality for quarter 3 onwards.
2. This Office reiterates the continuity of learning for the first two weeks of March 2021, guided by the provisions of DepEd's Academic Ease.
3. To provide guidance to SDOs, District Offices, public elementary and secondary schools, and the community learning centers, the following shall be considered for the first two weeks of March, basically Weeks 1 and 2 of Quarter 3:
 - a. Learning interventions shall be conducted. To foster academic ease, all activities including completion of self-learning modules scheduled for quarter 2, assessment of learning, clarifications and clearing house pertaining to quarter 2 lessons shall be done during this period to prepare the learners for quarter 3.
 - b. Region-initiated SLMs for Quarter 3 covering Week 1 of grades 4 to 12, are uploaded in the DepED-CAR Regional Office Google drive and can be accessed through this link: <https://tinyurl.com/CARmodules>
 - c. Available textbooks in the school shall be distributed to learners following guidelines for release and retrieval.
 - d. Use of other DepED-authorized platforms may be made like DepED Commons, DepED TV, and localized learning delivery efforts entailing online, audio, radio, video strategies may likewise be done.

e. Other relevant measures that the schools and SDOs have planned for this period shall be supported to ensure continuity of learning.

4. As per latest communication from the Central Office-Bureau of Learning Delivery, privately-procured Self-learning modules for Quarter 3 shall be delivered by middle of March 2021. For the information of the SDOs, G4-10 SLMs shall be delivered by suppliers to identified drop-off points:

5. SDOs are directed to continue developing SLMs for K to 3 for quarter 3 onwards. These SLMs shall undergo strict quality assurance at the SDOs to ensure the absence of any error and social content issue.

6. Moreover, each SDO assigned for particular learning areas shall continue developing SLMs for G4-10. These shall be initially quality assured at the SDO level and submitted to the RO for further quality assurance. After thorough review, the RO may harvest from other SDOs with available SLMs to comply with quality and urgency.
