

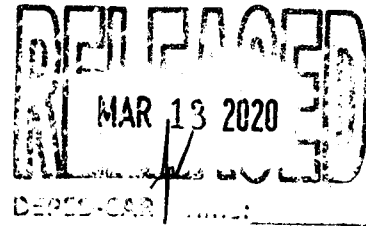



This refers to DepEd Memorandum No. 172, series 2019 entitled “1<sup>st</sup> Department of Education National Monitoring and Evaluation Conference” dated November 19, 2019 and its subsequent Advisory dated February 6, 2020.

Pursuant to the declaration of a State of Public Health Emergency (*Proclamation No. 922*) by President Rodrigo Duterte on 8 March 2020 and DepEd Memorandum No. 34, s. 2020 (*Fifth Set of Policy Directives of DepEd Task Force COVID-19*), the conduct of the **1st DepEd National Monitoring and Evaluation Conference shall be postponed indefinitely**.
