1. With reference to memorandum (DM-CI-2017 – Advanced Copy), the Department of Education (DepEd) through the National Educators' Academy of the Philippines (NEAP) is conducting a 5-day Capacity Building and Certification of Training Program Facilitators with the following objectives:

3. In this regard, the following RO NEAP Facilitators (Teams A, B, C & D) and other participants are recommended to attend the said training.

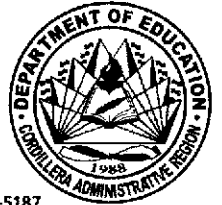
