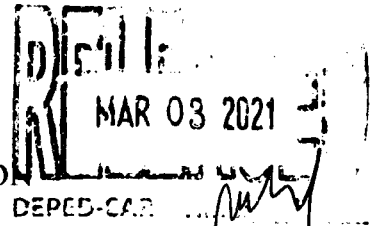

**SUBMISSION OF REPORTS RELATIVE TO DISTANCE LEARNING
DELIVERY FOR SCHOOL YEAR 2020-2021**

TO: OIC-Assistant Regional Director
Schools Division Superintendents
All Schools Division Offices
All Others Concerned

1. Pursuant to the implementation of the Basic Education Learning Continuity Plan (BE-LCP), information on implementation status is highly necessary to ensure that planned programs and activities are accomplished as intended.
2. In this regard, specific reports are requested from the SDOs with the following purposes:
 - a. Establish data on learners engaged in modular, online, and blended learning deliveries for proper resource appropriation;
 - b. Reflect quarterly assessment results of learning outcomes directed to enable schools to provide appropriate and urgent interventions to address failures or risks in failing; and
 - c. Determine best practices carried out relative to the implementation of distance learning delivery for research and scaling intents.
3. The following reports shall be accomplished through google sheet:
 - a. Updated data on number of learners engaged in modular, online, and blended learning delivery. Data encoding to be done from March 8 to 12.
 - b. Results of assessment of learning outcomes for Quarters 1 to 4 of SY 2020 to 2021. This shall be accomplished at the end of every quarter, to wit: March 15 to 19 (for Quarter 2 results); May 10 to 14 (for Quarter 3 results); and July 12 to 16 (for Quarter 4 results). Appended reports on specific schools reflecting failures and reasons for failures shall be indicated accordingly.
 - c. Best practices on distance learning delivery. Report encoding to be done from March 22 to 26.
