 CHILD PROTECTION CONCERNS SUCH AS CHILD ABUSE,  
 BULLYING, CAR AND CICL**

1. In line with the duties and responsibilities of the Regional Office and the Division Offices relative to DepEd Order No. 40, s. 2012, DepEd Order No. 55, s. 2013, and DepEd Order No. 18, s. 2015, there will be a consultation on April 29, 2016, 8:30 AM at DepEd CAR SNC Hall, Wangal, La Trinidad, Benguet.
2. The objectives of the activity are:
  - a. To come up with and agree on a systematic, effective and uniform way of reporting and monitoring child abuse, bullying, children at risk (CAR), children in conflict with the law (CICL) and child laborer cases within the region;
  - b. To constitute a Regional Child Protection Committee;
  - c. To enhance the forms provided by the Central Office relative to the above cases to suit the needs of the region for a more accurate profiling, needs-assessment, reporting, and referral;
  - d. To assess compliance and address issues on the preventive measures, remedial measures, and referral system;
  - e. To monitor the status of IEC and CAPB of CPC members in all schools;
  - f. To solicit recommendations from the field on policies, programs, and services, to address and prevent the above cases.
