1. Relative to the conduct of the Regional Achievement Test (RAT) for SY 2023- 2024, a quality assurance and validation of the RAT tools will be conducted on **March 18-20, 2024** to be held at DepEd CAR NEAP, Wangal, La Trinidad, Benguet.
