



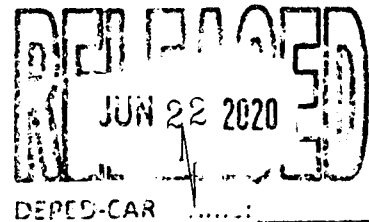

**AUTHORIZING THE CONDUCT OF ONLINE CONSULTATION MEETING  
 BETWEEN SDO SPED FOCAL PERSONS AND SPED TEACHERS**

1. In line with the thrust of ensuring the continuity of learning in the basic education amidst the COVID – 19, the Regional Office through the Curriculum Learning and Management Division (CLMD) is requesting all Schools Division Offices SPED Focal Persons to conduct an online consultation meeting with SPED Teachers on the proposed learning competencies for Learners with Special Education Needs (LSENs) and crafting of syllabus for Grades 1 and 2 Gifted and Talented/Fast Learners Class any day from June 22 – 26, 2020 at their own time and schedule duration.
2. The conduct of consultation meetings shall be guided by DO 11, s. 2020 or the Revised Guidelines on Alternative Work Arrangements in the Department of Education, which stipulates that School/CLC heads and personnel shall conduct meetings utilizing videoconferencing or teleconferencing technologies, whenever applicable, minimizing face-to-face interaction among personnel, and adhering to IATF and DOH restrictions on mass gatherings.
3. The activity aims to:
  - a. Identify and finalize the competencies for Learners with Special Education Needs (LSENs); and
  - b. Craft a syllabus for Grades 1 and 2 Gifted and Talented/Fast Learners class in English, Filipino and Science.
4. The output of this activity will fill – in the gaps for the LSENs in an inclusive or self – contained class and Grade 1 and 2 Gifted and Talented/Fast Learners Class and will serve as contextualized guide for teachers in the delivery of lessons and development of activity sheets or worksheets.
