

CONDUCT OF THE 2024 CARAA MEET

- Consistent with Republic Act 10588 or the Palarong Pambansa Act of 2013 and other existing DepEd policies on the Development and Strengthening of the school sports program, the 2024 Cordillera Administrative Region Athletic Association (CARAA) Meet with the theme, "Tara Cordillera, Maglaro at Magkaisa!" shall be held on April 15-19, 2024 at the Apayao Sports Complex, Luna Apayao.
- The annual regional sports event shall be hosted by the Local Government Unit of Apayao with the Schools Division Office (SDO) of Apayao. The schedule of activities for the said event will be the following:

- 3. In adherence to the memorandum issued by the Palarong Pambansa Secretariat on the **Conduct of the 2024 Palarong Pambansa Lower Meets**, this year's regional meet shall continue to adopt the **Winner-Take-All Policy** for all team sports (Basketball, Baseball, Softball, Football, Futsal, Sepak Takraw, and Volleyball) and the **Qualifying Standards** for measurable sports such as Athletics, Swimming, and Archery.
- 4. To ensure the smooth organization, coordination, conduct and promotion of the regional sports event, attached is the list of the permanent composition of the CARAA Board and the duly constituted technical management and working committees (Enclosure 1).
- 5. The Olympic Medal System shall be applied to determine the overall champion and rankings. Hence, ranking shall be based on the total number of gold, silver, and bronze medals to be contested in the different sports events.
- 6. In the absence of any updated Technical Guidelines by the Palarong Pambansa Secretariat before the conduct of the 2024 CARAA Meet, all sports shall be played in accordance with DM 035, s. 2023 on the Technical Rules, Regulations, and Guidelines of the different sports (regular and demonstration) which is downloadable from the DepEd-CAR website. In addition, a set of ground rules shall be formulated in concurrence with the coaches of the division delegations during the solidarity meeting.
- 7. Dancesport and Pencak Silat are considered regular sports for this year's CARAA Meet while Muay Thai shall be included as a demonstration sports. Medals awarded in the demonstration sports shall not be included in the medal count earned by the division delegations.
- 8. In line with DepEd's existing policies and guidelines in resolving protest on game technicalities of any sports event and protest on eligibility, complaints should be in written form, duly sworn statement of witnesses and/or evidence to support the same and shall be filed before the start of the second game of the concerned team. There shall be no protest fee to be collected from the protesting division delegation. Detailed information on the filing of protests on game technicalities and eligibility is contained in the respective technical guidelines of the different sports.
- 9. All selected officiating officials are required to attend the opening and closing programs. The list of Tournament Managers and Sports Officiating Officials is attached herewith as Enclosure 2.
- 10. Discipline, order, and cleanliness in billeting schools and playing venues shall be strictly monitored and implemented.
- 11. In compliance with DepEd Order No.13, series 2017, titled "Policy and Guidelines on Healthy Food and Beverage Choices in Schools and in DepEd Offices", all delegations shall promote healthy eating habits by ensuring the availability of healthy and nutritious food and beverages during the CARAA 2024.
- 12. All division delegations shall be accountable for the protection, welfare, and safety of their learner-athletes. All division delegates shall observe the integration of the principles of gender equality, gender equity, gender sensitivity, non-discrimination, and learner rights and protection. Therefore,

all SDOs shall establish the **Learner Rights and Protection Desk** to ensure the safety of the athletes. The Regional and the Division LRPO desks are required to conduct orientation on Learner Rights and Protection to all the delegations including the **parents, guardians, and drivers**. Moreover, each DepEd Division Office shall provide medical insurance coverage for its delegates.

- 13. All Schools Division Offices are expected to supervise learning interventions for their respective athletes by any available means of learning modality to compensate for missed lessons. Likewise, school heads shall take responsibility in assigning competent teacher / s to handle the affected classes in compliance with the 180 days non-negotiable teacher-learners contact time.
- 14. Coaches, Assistant Coaches, Trainers, Officiating Officials, Chaperons and members of division and regional technical working committees shall observe the No Alcohol, No Smoking, and No Gambling policies of DepEd. Violators shall be dealt with accordingly.
- 15. Coaches, Assistant Coaches, Chaperons. Trainers, Delegation Officials, Officiating Officials, and Members of the Technical Working Group Committees who will render services during weekends shall be given Service Credits and Compensatory Overtime Credits (COCs) for the non-teaching personnel based on the actual services rendered prior to and during the CARAA meet.
- 16. The Regional Office will provide caps, t-shirts, jackets, meals and transportation allowances to all the officiating officials and members of the technical management and working committees subject to the usual accounting and auditing rules and regulations.

I. RATIONALE
