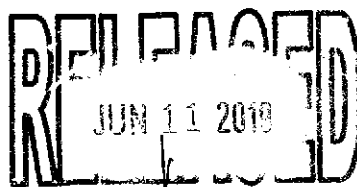

PARTICIPATION TO THE 2019 SECOND QUARTER NATIONAL SIMULTANEOUS EARTHQUAKE DRILL (NSED)

To: Schools Division Superintendents
School Heads, public and private elementary and secondary schools

1. The 2019 second quarter National Simultaneous Earthquake Drill (NSED) is scheduled at 2:00 PM on June 20, 2019, with the following objectives:
 - a. To evaluate the readiness and awareness of learners and DepEd personnel to earthquakes; and
 - b. To evaluate the coordination and communication mechanisms during earthquake procedures and response.
2. All public and private elementary, junior and senior high schools are enjoined to participate in this activity. Participating schools are also encouraged to coordinate with their local DRRM Councils and other concerned agencies prior to the conduct of the activity for technical assistance and to ensure the successful conduct of the activity.
3. Schools Division Disaster Risk Reduction and Management coordinators (PDO II-DRRM) are instructed to monitor the conduct of the activity and submit a documentation and post-activity report to the Regional DRRM Coordinator on or before July 6, 2018 using the attached template (Annex "a").
4. School DRRM Coordinators shall submit their reports to their respective Schools Division DRRM Coordinators on or before June 22, 2019 while Schools Division Coordinators shall submit the consolidated division report to the Regional DRRM Coordinator, copy furnished their Schools Division Superintendents on or before June 29, 2019.
5. Immediate and wide dissemination of this Memorandum is desired.
