**STATUS OF PRIVATE SCHOOLS RE: GOVERNMENT PERMIT/RECOGNITION**

1. Per result of the validation and inspection of the Regional Validation Team (RVT) on the Application of Private Schools for Government Permit/Recognition for SY 2019 – 2020, it was found out that there were private schools which are no longer operating due to voluntary closure and there were also private schools which are operating without Government Permit/Recognition.
2. With the foregoing, the Division In-Charge of Private Schools with the Division Assessment and Inspection Team (DAIT) are hereby directed to conduct monitoring to all private schools to check on the actual status of the school concerned. Reports shall be submitted to this office on or before **July 15, 2019**. Attached is the template to be used for consolidation. This office shall not entertain reports/emails from individual schools but rather a consolidated report prepared by the Division In-Charge of Private Schools endorsed by the Schools Division Superintendents.
3. The reports shall serve as basis of this office in publishing the list of Private Schools with Government Permit/Recognition in the Region. Further, it will be utilized in the updating of the Learner's Information System (LIS) of the Private Schools.
