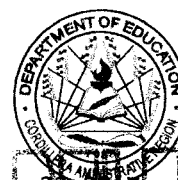

SEARCH FOR BRIGADA ESKWELA BEST IMPLEMENTING SCHOOLS FOR SY 2017-2018

To: Schools Division Superintendents
Heads, Public Elementary and Secondary Schools
All Others Concerned

- To give due recognition to public elementary and secondary schools whose efforts in the implementation of Brigada Eskwela Program are exemplary, the **Search for Brigada Eskwela Best Implementing Schools is conducted every school year.**
- To effectively implement the selection process in the **Search for Brigada Eskwela Best Implementing Schools for School Year 2017-2018**, this Office issues the criteria in the selection of Brigada Eskwela Best Implementing Schools.
- The Brigada Eskwela Best Implementing Schools are categorized into four: (a) Small School Category; (b) Medium School Category; (c) Large School Category, and (d) Mega School Category.
- There shall be eight (8) entries per Schools Division: two (2) small school category with 9 and below number of teachers, for both elementary and secondary levels, two (2) medium school category with 10 - 29 number of teachers for elementary level and 10 - 25 number of teachers for secondary level, two (2) large school category with 30 – 50 number of teachers for elementary level and 26 -100 number of teachers for secondary level, and two (2) mega school category with 51 and above number of teachers for elementary level and 101 and above number of teachers for secondary level. Each category shall have one (1) entry for elementary level and one (1) for secondary level. Please refer to DepEd Memorandum No. 43, s. 2017 for the other criteria of selection.
- The deadline for submission of all entries C/o Education Support Services Division (ESSD) this Office will be on or before July 14, 2017. The timeline of Brigada Eskwela activities and the selection criteria on the Search for the Brigada Eskwela Best Implementing Schools shall be followed strictly by all concerned.
- Monitoring/evaluation/validation of all entries shall be conducted on July – August, 2017 by the Regional Monitoring Team.
- Submission of Schools Division Consolidated Brigada Eskwela Accomplishment Report to the External Partnerships Service, Central Office via email to rolly.soriano@deped.gov.ph and copy furnished this Office will be on or before July 25, 2017.
- Immediate dissemination of this Memorandum is desired.
