RE-ITERATION OF DEPED ORDER NO. 39, S. 2017-2022 AND DO. NO. 18, S, 2019 ON THE IMPLEMENTATION OF SCHOOL-BASED FEEDING PROGRAM (SBFP)

To: Schools Division Superintendents
All Schools Divisions

1. This memorandum is for the reiteration of Department of Education Order No. 39, s. 2017-2022 and DO No. 18, s. 2019 for the implementation of the School-Based Feeding Program (SBFP) in the region.
2. The School-Based Feeding Program shall cover all severely wasted and wasted Kindergarten to Grade 6 learners in all public elementary schools. It aims to contribute in the increase of class participation among the beneficiaries.
3. The funds for the First tranche (60%) have been downloaded to all schools division offices, to facilitate the early start of the feeding and ensure completion of 120 feeding days until December 2019. The allocation for this year was based on the number of severely wasted and wasted pupils - Baseline Nutritional Status SY 2018-2019. The 2nd tranche to be downloaded (40%) will depend on the actual number of severely wasted and wasted learners identified after the baseline nutritional status assessment this June 2019.
4. Feeding activities shall start not later than July 31, 2019.
5. Schedule of submission of reports:
 - Validated Baseline Nutritional Status Report SY 2019-20 - on or before **August 15, 2019**;
 - List of recipient schools using **SBFP Forms 2 & 3 - on or before August 15, 2019**;
 - **SBFP Form 10** -Financial report on the downloading of funds to schools **on or before August 5, 2019 and November 8, 2019**;
 - Report on excess funds: SDO to RO - not later than **October 7, 2019**; and
 - Consolidated program terminal reports with analysis and recommendations to the Regional Office on or before **February 10, 2020**.
