

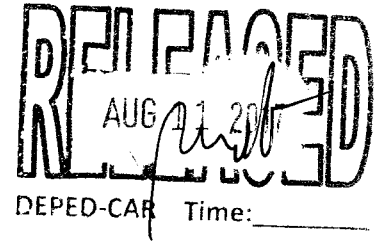



Per DepEd Order No. 9, series of 2017 (Implementing Guidelines on the Release and Use of Funds for Fiscal Year 2017), the implementation of FY 2017 Special Hardship Allowance (SHA) is subject to the issuance of guidelines from the DepEd Central Office (CO).

Since the review of the new SHA guidelines is still ongoing, the Department shall continue to adopt the guidelines and criteria stipulated in National Budget Circular (NBC) No. 514, s. 2007 (Guidelines on the Grant of Special Hardship Allowance), in the determination of SHA payment for qualified teachers in FY 2017.

Attached to this memorandum is the allocation of SHA per region. In cases where the regional allocation is deemed deficient, Regional Offices are hereby instructed to submit requests for additional funds, together with supporting documents and computations, to the DepEd CO-Budget Division on or before August 25, 2017.

Strict compliance to the provisions of the above-mentioned NBC must be observed by all concerned. Those involved in the processing of SHA shall be held accountable and liable for any payments that are not in accordance with the said Circular.

Please be guided accordingly. Thank you.
