

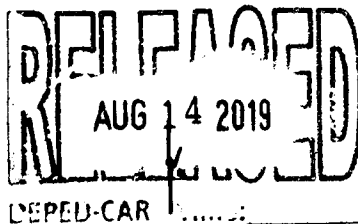

REGIONAL TRAINING OF SCHOOL PAPER ADVISERS ON CAMPUS JOURNALISM


To: Schools Division Superintendents
All Divisions

1. Pursuant to Republic Act (RA) No. 7079, otherwise known as the Campus Journalism Act of 1991, and in support to the DepEd-CAR's desire to capacitate school paper advisers, a regional training of new school paper advisers or with one (1) year in school paper advising will be held on September 2-3, 2019 at the NEAPR, DepED-CAR Regional Office Compound, Wangal, La Trinidad, Benguet.
2. The training aims to:
 - a. discuss the different genres in Campus Journalism and Campus Paper Management;
 - b. capacitate the regional trainers on the current trends and new development in campus journalism and digital communication media;
 - c. provide a healthy forum in addressing issues and concerns relative to the conduct of any Press Conferences; and
 - d. finalize each division's raining and return of service plans.
3. Each division shall send four (4) new school paper advisers, one (1) English, one (1) Filipino from the Elementary and one (1) English, one (1) Filipino from the Secondary.
