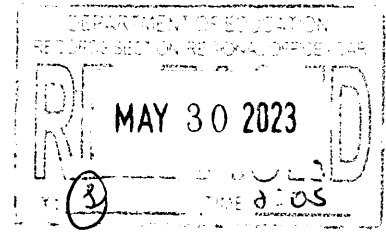

**REITERATION ON THE SUBMISSION OF LOCALLY DEVELOPED
LEARNING RESOURCES TO THE REGIONAL LEARNING
RESOURCE MANAGEMENT SYSTEM (LRMS)**

To: Schools Division Superintendents
Schools Division Offices
All Others Concerned

1. In connection to Regional Memorandum No. 061, 2019, entitled "Submission of Locally Developed Learning Resources to the Regional LRMS", this Office through the Curriculum Learning and Management Division – Learning Resource Management Section reiterates the submission of Locally Developed Learning Resources following the guidelines:

- a. There shall be eleven (11) Learning Resources (LRs) locally developed based on the Least Learned Competencies (LLCs) or critical contents in any Learning area and Grade Level per SDO to be submitted quarterly following the schedule below:

Quarter	Deadline of Submission	Release of Results from LRMS
Third	September 15, 2023	September 15, 2023
Fourth	December 15, 2023	December 15, 2023

- b. The Learning Resources (LRs) shall be packaged along with the DLL with attached Quality Assurance (QA) Forms CO form 7.10 (IPR), Form 7.20 (Educational Soundness) Form 7.6 (Evaluation Form) Form 7.14 (Social Content Evaluation) and CAR-QF-CLMD-LRMS-02 (Validation for Contextualized/Elders Certificate/FPIC).
- c. Locally developed Learning Resources (LRs) for quarterly submission are expected to have undergone thorough review and quality assurance by the Division Quality Assurance Team to facilitate uploading to the portal.
- d. The target of the Learning Resources (LRs) to meet the standards shall prevail and any variance will cause backlog to the Schools Division Office's quarterly submission.

2. The Curriculum and Learning Management Division- Learning Resources Management Section shall facilitate the distribution of the submitted Learning Resources (LRs) to the Quality Assurance Team of CLMD who are identified as follows:
