



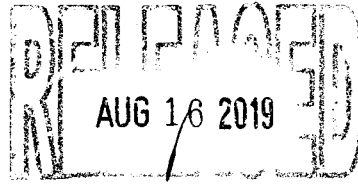

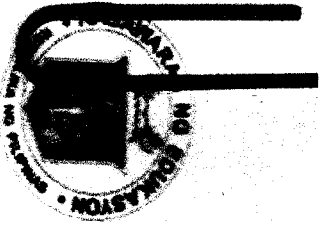

1. Pursuant to DepEd Order No. 12 s. 2019 Re: Implementing Guidelines on the Utilization of Program Support to Operation in the Alternative Learning System in the Regional Office Calendar Year 2019 and DepEd Order No 3 s. 2019 Re: Policy Guidelines on the implementation of enhanced Alternative Learning System (ALS 2.0) Basic Education Curriculum (BEC), the regional office will download to the Schools Division Offices for the different ALS activities relative to the expansion on the implementation of ALS programs and projects.
2. The different activities being downloaded to each division are as follows:
 - a.  - d. ALS K-12 BEC Training for Literacy Volunteer/Service Provider being contracted including Literacy Volunteer from LGU/GOs/NGOs partners allotted from SARO No. OSEC-19-1252 per DO 12 s. 2019;
