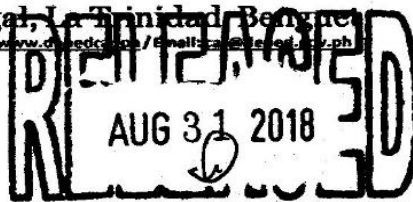

Regional Consultative Conference on Learning Resources with Culturally Insensitive Information cum IPed Roadmap Revisit

To: **Schools Division Superintendents**
All Schools Division Offices

1. In view of Deped-CAR's vision to set policy directions as regards the delivery of learning resources and efficient implementation of IPed, the Regional Office will be conducting a **Consultative Conference on Learning Resources with Culturally Insensitive Information cum IPed Roadmap Revisit on September 10 and 11, 2018** at the NEAPR Conference Hall, Wangal, La Trinidad, Benguet.
2. Objectives of this activity are for the RO, SDO personnel, and Elders to: arrive at a consensus on appropriate actions to be taken as regards learning materials in circulation containing culturally-insensitive information; recommend policies for possible regional adoption; and refine the roadmap to set policy directions for the Region.

SDO Coordinators for Private Schools in the 8 Divisions are requested to inform the School Heads who are preferably the Presidents of the Association of Private Schools per Division of their participation on **September 10 only**. Their presence is very crucial in resolving the concern about the circulation of learning resources with culturally insensitive information in private schools.
5. Accommodation and Meals (breakfast, AM snack, lunch, PM snack, and dinner) for 2 days will be charged to the 2018 IPEd Funds in the Region. Accommodation for the Elders and participants from the SDOs and private schools outside Baguio City and La Trinidad will be at the NEAP Dormitory. First meal will be breakfast of September 6 and last meal will be dinner of September 7.
6. Travel expenses and other meals not covered within the activity duration will be charged to local funds subject to the usual accounting and auditing rules and regulations.
