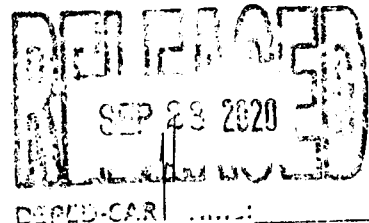

**DIVISION ASSIGNMENT ON THE DEVELOPMENT OF  
TLE/TVL LEARNING RESOURCES**

1. This is in line with the agreement during the Virtual Meeting with EPP/TLE/TVL Regional and Division EPS/Focals held on August 24, 2020, that each division shall develop Self-Learning Modules for particular TLE/TVL component and specialization in a grade level as appropriate to ensure the availability of quality learning resources in TLE/TVL.
2. The SLM to be developed shall be compliant with the guidelines and elements stated in Regional Memorandum 91, s. 2020 and the quality assurance process set by the LRMS. The content shall be aligned with the learning competencies specified in the CG 2016 if MELCs is not available.
3. The developed module shall have undergone Quality Assurance at the division level before subjecting to Regional QA to ensure that the materials are free from content, language, layout and format errors, plagiarism and copyright infringement as well as compliance with the prescribed SLM elements with attached QA Tool and Form.
4. The Division EPS in-charge of LRMS, with the assistance of the EPP/TLE/TVL Division EPS, shall be responsible in submitting the modules and evaluation tools.
5. Division QA digital copies of the SLMs with accomplished QA tools shall be submitted in word document format to **lrmdshelpdesk.depedcar@gmail.com** on or before October 30, 2020. Please refer to Enclosure A as to the Division Assignment on the Development of Quarter 2 Self-Learning Modules.
