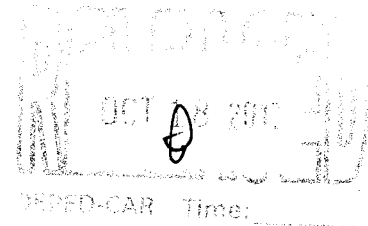

Pursuant to OO-LA-2017-0004, otherwise known as CREATION OF A TECHNICAL WORKING GROUP (TWG) TO REVIEW AND AMEND DEPARTMENT ORDER NO. 88, S. 2010 AS AMENDED BY DEPARTMENT ORDER NO. 11, S. 2011 OTHERWISE KNOWN AS THE REVISED MANUAL OF REGULATIONS FOR PRIVATE SCHOOLS IN BASIC EDUCATION, the TWG will be conducting a Seminar-Consultation for External Stakeholders for the amendment of DO 88, s. 2010, on the following dates with their respective venues:
