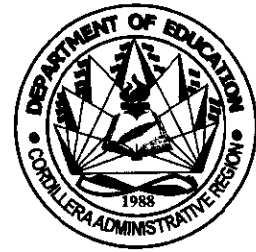

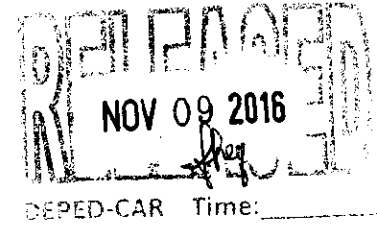

1. Pursuant to the Un-numbered Memorandum released by the Department of Education, Indigenous Peoples Education Office on August 15, 2016 on the **Utilization of Remaining FY 2015 Indigenous Peoples Education (IPed) Program Funds**, this office will be conducting a **Regional Capacity Building for Indigenous Peoples Community Representatives Engaged with Deped in Curriculum Contextualization** on November 27-30, 2016 & December 1, 2016 at 8 o'clock to 5 o'clock in the afternoon. 2. The objectives of this capacity building are the following:

- a. To familiarize community representatives and representatives of the NCIP provincial/regional offices with the rationale and current developments in DepEd's IP Education Program
- b. To level-off on DepEd's policies, processes, procedures, mechanisms, structures relevant to implementing IP Education
- c. To develop a platform of collaboration that would harmonize perspectives, policies and programs, rights and duties, as well as roles and functions of the different participating institutions for IPed implementation
