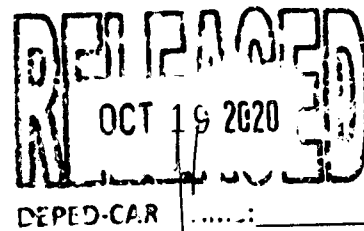

ADDENDUM TO REGIONAL MEMORANDUM (RM) NO. 287 - SUBMISSION OF PARTICIPANTS FOR PROJECT PANSIGDAN PHASE 1 SKILLS TRAINING

1. In compliance to NBC 580, s. 2020¹ and RA 9184² restrictions, RM No. 287, s. 2020 calling for submission of project PANSIGDAN nominations shall be held in abeyance, to be implemented upon lifting of discontinuance by the national government as well as completion of documentary requirements by this Office.
2. Thus, Item No. 6 indicating the implementation schedule shall be modified accordingly on a succeeding addendum.
3. In this connection, to ensure the continuity of learning in basic education amidst the COVID-19 pandemic as embodied in the DepEd CAR Learning Continuity Operational Plan, this Office through the Human Resource Development Office (HRDD) shall conduct the PANSIGDAN Online Skills Training on **November 11 to 13, 18 to 20 and 25-26, 2020** via google meet through this link: meet.google.com/hmw-sibr-btu
4. The purpose of this training shall enable the participants to:
 - a. Calibrate developmental needs addressing the K to 10 Critical Content across learning areas;
 - b. Establish skills-based competences demanded for the effective delivery of the Most Essential Learning Competencies (MELCs); and
 - c. Value the importance of professional development programs and continuous learning amid pandemic.
