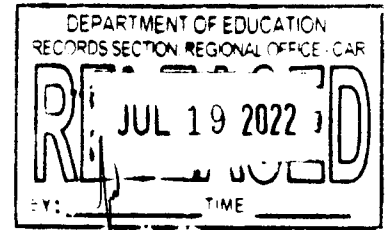

**REGIONAL TRAINING OF TRAINERS (TOT) ON SEXUALLY HEALTHY
AND PERSONALLY EMPOWERED ADOLESCENTS (SHAPE-A)**

1. The Department of Education Cordillera Administrative Region with the strengthened partnership with the Commission on Population and Development (POPCOM) will conduct a limited face to face Training of Trainers on Sexuality Healthy and Personality Effective Adolescents on **July 18-22, 2022** at H100 ECOLODGE Magsaysay Avenue Baguio City.

2. The objectives of this activity are:

- a. Provision of support to DepEd-CAR to sustain AHDP – Comprehensive Sexuality Education (CSE) efforts in the region through the conduct of AHDP orientation and capacity building activities for teachers and school heads in the Schools Division of Abra, Apayao, Ifugao, Kalinga and Mt. Province;
- b. Equipping teachers with knowledge and skills on AHDP – Comprehensive Sexuality Education (CSE) which they can teach to their students;
- c. Provision of materials & references needed for the conduct of AHDP orientation and capacity building activities for teachers in the Schools Division of Abra, Apayao, Ifugao, Kalinga, and Mt. Province;
- d. Enrichment/ integration of ASRH concepts into the curriculum and adolescent/ youth programs in schools through AHD Tool kits in support to the implementation of age-and-development-appropriate education on reproductive health.

3. Participants to this activity are Teachers, School Heads and Education Program Supervisors of the Schools Division of Abra, Apayao, Ifugao, Kalinga and Mt. Province. Teacher participants are entitled for service credits in accordance to DepEd Order no. 53 s. 2003.
