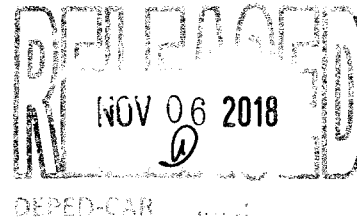

SUBJECT : **Gender Responsive Regional Training-Workshop on Child Protection**

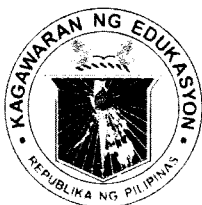

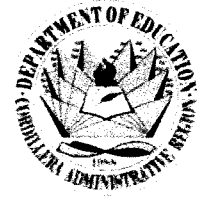
