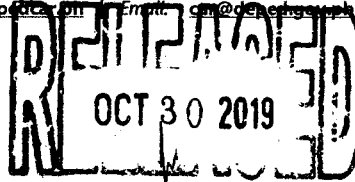

Conduct of Cybersafety in Schools Roll-out

1. The Department of Education thru the Office of the Undersecretary for Legal Affairs conducted a training of trainers on Cybersafety in Schools for Cordillera Administrative Region on September 16-20, 2019 in Baguio City which was attended by participants from all the Schools Division Offices and the Regional Office;
2. Simultaneous to the said activity, DepEd Order No. 25, s 2019 entitled *"Guidelines on the Release, Use, Reporting, Monitoring and Evaluation of Capacity Building Funds for Child Protection for Fiscal Year 2019, managed by Regional Offices"* was issued stating that the amount of Php506,000.00 will be downloaded to the Regional Offices for the conduct of capacity-building programs and activities relative to child protection. This includes the conduct of training on Cybersafety in Schools for Teaching and Non-Teaching personnel;
3. Considering that the training of trainers on Cybersafety in Schools for DepEd CAR has just been concluded, and to ensure maximum participation of teaching and non-teaching personnel in the field, all Schools Division Offices and the Regional Office shall conduct a roll-out on the Cybersafety in Schools Training;
4. Consequently, the amount of Php56,200.00 is downloaded to all the Schools Division Offices, and the amount of Php56,400.00 is retained in the Regional Office for the roll-out. However, if the funding is insufficient to cover the capacity-building activity, additional expenses shall be charged to the Training and Development or Gender and Development Funds or through support of external partners;

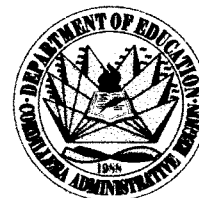

7. The Division Offices must submit a narrative report after the conduct of activity and a physical and financial accomplishment report on the utilization of funds following Enclosures 2 and 3 of DepEd Order No. 25 s 2019;
