COMMENDING THE PARTICIPANTS OF THE GENDER RESPONSIVE REGIONAL TRAINING-WORKSHOP ON CHILD PROTECTION AS CERTIFIED REGIONAL CHILD PROTECTION ADVOCATES PURSUANT TO REGIONAL MEMORANDUM NO. 381, S. 2018

1. Pursuant to DepEd Order (DO) No. 40, s. 2012 entitled DepEd Child Protection Policy, DO 55, s. 2013 entitled Implementing Rules and Regulations of the Anti-Bullying Act of 2013, and DO 18, s. 2015 entitled DepEd Guidelines and Procedures on the Management of Children-at-Risk (CAR) and Children in Conflict with the Law (CICL), the Department of Education (DepEd) shall provide special protection to children gravely threatened or endangered by circumstances which affect their normal development and over which they have no control, and assist the concerned agencies in the rehabilitation of affected children.
2. To further strengthen the implementation of DepEd policies on Child Protection and to reiterate DepEd's zero tolerance policy for any act of child abuse, exploitation, violence, discrimination, bullying and other forms of abuse, the Regional Office has conducted a training on child protection entitled "GENDER RESPONSIVE REGIONAL TRAINING-WORKSHOP ON CHILD PROTECTION" which aims to train, designate and produce Certified Regional Child Protection Advocates:
 - a. Who shall help promote positive discipline, provide technical advice or assistance to the schools divisions on child protection cases brought to their attention, and recommend actions to address the same based on existing Child Protection related laws and pertinent DepEd issuances;
 - b. They can also assist in the referral of cases to other government, non-government or other agencies for appropriate interventions or further case management;
 - c. As Certified Regional Child Protection Advocates, they can be tapped as Resource Person or Facilitator on trainings and other information, education, campaign (IEC) involving child protection or other trainings promoting the rights of children in order to create a *child-friendly, gender-sensitive, safe and motivating environment for learners.*
3. Therefore, the following 31 women and 25 men DepEd Personnel who have successfully completed the thirty-two (32) hours training entitled "Gender Responsive Regional Training-Workshop on Child Protection", are hereby **CERTIFIED as REGIONAL CHILD PROTECTION ADVOCATES** within their respective Division and Regional Office and are eligible to perform the foregoing functions specified in

paragraph 2 hereof:

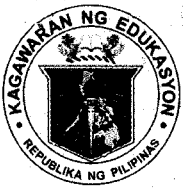
