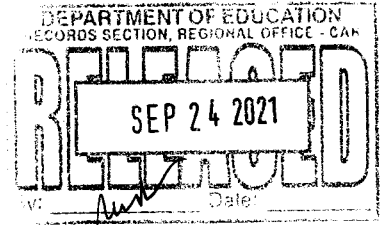

**CONDUCT OF ONLINE FIELD VALIDATION OF MULTIMEDIA LEARNING  
 FORMAT FOR SENIOR HIGH SCHOOL (SHS) PRIMALS**

1. In compliance with DM-CI-2021-00218, the Bureau of Learning Delivery-Teaching and Learning Division (BLD-TLD) shall conduct an Online Field Validation of Multimedia Learning Format for SHS PRIMALS Supplementary Materials in selecting learning areas. The validation will be held on September 24-28, 2021.

2. The activity aims to validate the SHS supplementary materials in terms of content, format/technical design, alignment of the lesson and activities/tasks with the objectives, presentation and organization, and accuracy and up-to-datedness of information of the materials. The relevant results of the validation will be utilized on the finalization of said materials.
