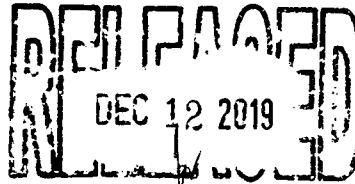

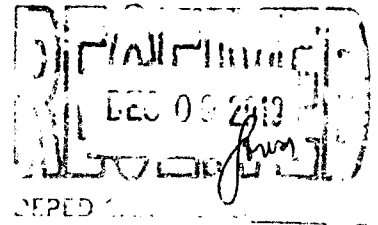

The Department of Education's vision, mission and core values lead the promotion of the Philippine culture and values. This includes fostering and awakening Filipino nationalism and patriotism towards equitable, accessible and relevant basic education for all.

The Bureau of Learning Delivery-Teaching and Learning Division (BLD-TLD) will conduct an activity under the Balik Kasaysayan Program entitled *Workshop on the Finalization of Proposed Balik Kasaysayan Program Policy* on December 17-20, 2019 at DepEd NEAP NCR, Marikina City. This activity aims to have a final draft of the proposed Balik Kasaysayan Program Policy and thus includes the consolidated data gathered from Araling Panlipunan (AP) teachers through bit.ly/AP_Teach_Profile in the draft policy. All AP teachers in the region are required to accomplish the form before the activity.

The DepEd, spearheaded by BLD-TLD, invites two supervisors in-charge of AP. Output of this activity is the final draft of the Balik Kasaysayan Program Policy.

Board and lodging, travel expenses (most economical), and other incidental expenses relative to these activities shall be charged against DepEd Central Office's 2018 Continuing HRTD Funds subject to the usual accounting and auditing rules and regulations.

Travel expenses of participants may be reimbursed from their respective regional offices. Basis of this is the attached regional SAROs. To facilitate reimbursement of participants, the regional offices may opt to download the travel expenses reimbursement or cash advance of the participants to their respective divisions. It is understood that the regional offices were advised by the central office of this newly introduced mode of reimbursement.
