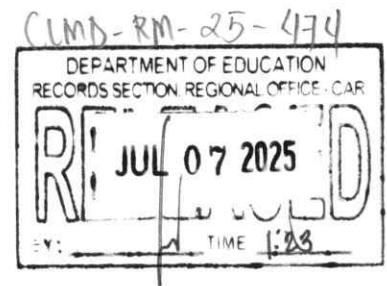

ON THE STRENGTHENED SENIOR HIGH SCHOOL

1. In view of the DepEd Memorandum DM-OUHROD-2025-1307, this Office, through the Curriculum and Learning Management Division (CLMD), will conduct a **Planning and Training Orientation of Field Implementers on the Strengthened Senior High School Pilot Implementation on July 10 & 11, 2025**.
