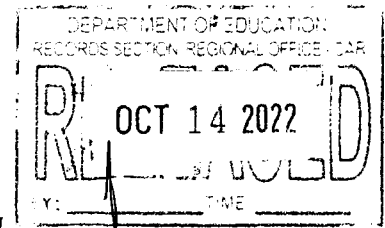

CONDUCT OF PROGRAM IMPLEMENTATION REVIEW (PIR) OF THE NATIONAL EDUCATORS ACADEMY OF THE PHILIPPINES (NEAP) WITH THE SCHOOLS DIVISION OFFICES (SDOs)

1. Pursuant to DepEd Order No. 030, s. 2021, or the Multi-Year Implementing Guidelines on the Allocation and Utilization of the Human Resource Development Fund for Teachers and School Leaders, this Office shall ensure that implementation of Professional Development Programs (PDP) are programmable and accountable.

2.
